# ABOUT US

The Mexican Chamber of Commerce in Great Britain (MexCC) is an independent, non-profit, private membership organisation which helps businesses trading or doing business in Great Britain and Mexico to connect and pursue business opportunities in an efficient and cost-effective manner.

The MexCC is both the first and the only Mexican Chamber in Europe and is thus recognized by the British, Mexican and international business communities. Funded in 2011, we work in close contact with the Mexican Embassy in London, ProMéxico, and the Mexican Tourism Board as well as other London-based organisations with Mexican connections while still keeping our private agenda.

The Chamber is also linked to British bodies and institutions such as, UK Trade and Investment (UKTI), the British Embassy and Business Centre in Mexico and is an active member of both the Council of Foreign Chambers of Commerce (CFCC) and the Council of Iberoamerican Chambers (CIAC) with whom we regularly organize joint events.
